Below are two letter templates for your use in contacting your state senator or representative about your right to practice in your state:

SAMPLE LETTER #1: Longer Letter

Dear,
I am a Biodynamic Craniosacral Therapy (BCST) practitioner/teacher living and practicing in [city], [state]. [Write a little bit about yourself and your work, emphasizing learning, improving function. If you have another license or certification, you can write about how the BCST is different.]
Please do not pass proposed changes to Massage Therapy Law, which would create bodywork licensure requirements for practitioners of Biodynamic Craniosacral Therapy.
As your constituent, I urge you to oppose the proposed changes to Massage Therapy Law.
I have been a Biodynamic Craniosacral Therapy (BCST) practitioner/teacher since I graduated from an accredited training program of 700 hours, and I've completed over hours of continuing education. As a BCST practitioner/teacher, I use subtle, non-manipulative touch to guide my clients'/students' attention to the subtle movements of Health and dysfunction within the fluids and tissues of the body.
I have been a member of the Biodynamic Craniosacral Therapy Association of North America (BCTA/NA) since My certification requires that I abide by the BCTA/NA Standards of Practice, Code of Professional Conduct, and requirements for use of service marks owned by BCTA/NA.

A bodywork board should not oversee BCST practitioners/teachers. The practice of the BCST requires 700 hours of training over at least a 3 year period for initial certification. Practitioners also meet yearly continuing education standards. BCST teachers are effectively regulated by the Biodynamic Craniosacral Therapy Association of North America (BCTA/NA). Finally, what they do is completely different than bodywork.

In summary it is ineffective and inefficient to have a bodywork board involved in any manner in the regulation of Biodynamic Craniosacral Therapy.
